- 9. **BREAKS:** Only one 10-15-minute break for each hour of performance is allowed unless other arrangements are made with Purchaser.
- **10. GUIDELINES FOR PRIVATE PARTIES:** LTB Talent(s) and accompanying personnel should refrain from eating or drinking on the premises of all private parties unless invited to do so by Purchaser. No guest of LTB Talent(s) are permitted without the consent of the Purchaser.
- 11. THE PURCHASER shall at all times have complete supervision, direction, and control over the services of LTB Talent(s) on this engagement and expressly reserves the right to control the manner, means, and details of the performance of the services by LTB Talent as well as the ends to be accomplished as long as it does not impinge upon the artistic expression and freedom of the LTB Talent purchased.

The agent of the Purchaser will immediately contact Agent should any conflict arise with the LTB Talent relative to the enforcement of Purchaser's instructions stipulated in this Agreement related to the selection and manner of performance.

12. THE PURCHASER or any leader, manager, or representative thereof agrees and guarantees to pay 35 % percent of the Agreed Cash Compensation (See 7 above) in the form of a Deposit for personal services, booking fee, contract fee, and telephone expense rendered and incurred in this transaction to Agent. This Deposit is due and payable when all parties have signed this Contract and must be paid within ten days prior to the date that the LTB Talent(s) is to perform for the Purchaser except where Agent has already retained said Deposit.

If leader or any key personnel of LTB Talent(s) purchased herein are rebooked into this or any establishment represented by the Purchaser (including chain, subsidiary, or contracted buyers of LTB Talent's services) within 12 months from the termination of this Agreement, Purchaser and those additional parties shall be jointly and severally liable for payment to Agent for additional Deposit(s) in the rate set forth in this Agreement.

- **13. THE AGREEMENT** of the LTB Talent to perform is subject to proven detention by sickness, accidents, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond their control. If LTB Talent is unable to perform, Agent will take reasonable measures to provide a suitable alternate LTB Talent.
- **14. THIS CONTRACT** constitutes the sole, complete, and binding agreement between the LTB Talent(s) and the Purchaser. Agent and its employees act only as agent,

consultant or manager, and assumes no responsibility or liability as between the Purchaser and the LTB Talent(s).

Covenants herein contained between said Purchaser, their leader, manager or representative and Agent are intended to be binding as between said LTB Talent(s), their leader, manager or representative and Agent.

- **15. MEMBERS OF UNIONS OR GUILDS**, which may include leader and members of this unit, agree to accept sole responsibility for complying with the rules and regulations of said unions or guilds of which they may be members.
